

## **Plumboss “Back To Work” Giveaway – Terms & Conditions**

### **1. Promoter**

The promoter is Plumboss Australasia Pty Ltd (ABN 43 654 071 799) of 3 Jamieson Place, Glendenning NSW 2147, Australia (“Promoter”).

Tradelink is a retail partner only and is not the promoter.

### **2. Promotion Period**

The promotion runs from 12:00am AEDT on Sunday 1 February 2026 to 11:59pm AEDT on Saturday 28 February 2026 (“Promotion Period”).

### **3. Eligibility**

Participation is open to Australian residents who are registered Tradelink trade customers and authorised to transact on a Tradelink trade account.

Employees and contractors of the Promoter and Tradelink, and their immediate families, are not eligible.

### **4. How to Participate and Redeem**

Eligible customers who purchase Plumboss products from participating Tradelink stores during the Promotion Period will accumulate spend toward a prize. All Plumboss products qualify and there are no product exclusions.

Redemption is based on cumulative spend during the Promotion Period and is limited to one (1) prize per Tradelink trade account.

To redeem a prize, customers must be contactable via the email address or phone number recorded on their Tradelink account. Following the Promotion Period, Tradelink will attempt to contact eligible customers by email, or by phone if no email response is received or no email address is available.

Customers must confirm their selected prize from the applicable spending tier either verbally or in writing. Customers have four (4) calendar weeks from the date of first contact to confirm their selection. If a customer cannot be contacted or does not confirm their selection within this period, their entitlement to a prize will be forfeited.

If a selected prize is unavailable due to stock constraints, an alternative prize of equal or greater value within the same spending tier may be offered. Where no suitable alternative is available, the selected prize will be supplied at the next available date.

Purchase is required. Only valid purchases made during the Promotion Period are eligible.

**7. No Element of Chance**

This promotion is a purchase-based giveaway and does not involve a draw, competition or element of chance.

**8. Permits**

This promotion is conducted under permit exemptions applicable to trade promotion giveaways. No permits are required.

**9. General Conditions**

The Promoter may verify eligibility and disqualify any participant who tampers with the promotion or breaches these Terms & Conditions.

To the extent permitted by law, the Promoter excludes liability for any loss or damage arising from participation or a prize, except for liability that cannot be excluded under Australian Consumer Law.

**10. Australian Consumer Law**

Nothing in these Terms & Conditions limits or excludes rights under the Competition and Consumer Act 2010 (Cth) or Australian Consumer Law.

**11. Privacy**

Personal information collected will be used solely to administer the promotion and handled in accordance with the Promoter's Privacy Policy.

Participation does not constitute consent to receive marketing communications from the Promoter, and personal information will not be added to the Promoter's marketing databases.

Participants may receive communications from Tradelink in accordance with Tradelink's privacy policy and existing communication preferences.

**12. Governing Law**

These Terms & Conditions are governed by the laws of New South Wales, Australia. Entrants submit to the non-exclusive jurisdiction of the courts of

Australia. Nothing in this clause limits any rights or remedies available under Australian Consumer Law.
